I did make a verbal copy ... When I need ask a one minute delay. So you lived in the apartment on Via della Pergola 7 number?

LM:

Yes.

GM:

When she went to live in this apartment?

LM:

I went the last August.

GM:

2007.

LM:

2007 and at the time we were just me and Filomena, then we ...

GM:

It was found together with Filomena?

LM:

With Filomena Yes.

GM:

Then you were before, were you two.

LM:

Yes.

GM:

Then, who is?

LM:

Then we put ads to look for roommates on both the sell and I find that directly to the University for foreigners which we found Meredith and Amanda.

GM:

And who came first?

LM:

She arrived first Amanda, Amanda who came in early September, saw 1 apartment, liked it, but was not directly in the House with us because he had to go to Germany for which he checked into room but actually came home the last of September.

GM:

And then the last days of September Amanda permanently ...

LM:

Permanently entered into home Yes.

GM:

And Meredith?

LM:

And Meredith entered the second week of September, I don't recall • exactly on the day but mid September actually came into the House with us.

GM:

Hear the rent as it was?

LM:

1200 Euros, 300 euros per person.

GM:

And when you had to pay?

LM:

I had to pay by 5 of each month.

GM:

Feel the keys to the door outside, the outer door looking over the pitch and then the gate who had 1 '?

LM:

All the roommates.

GM:

All of them had problems that door?

LM:

Yes, she broke we were necessarily lock the door would remain open otherwise.

GM:

Yes, and then to close it you had to force close it.

LM:

Yes key.

GM:

It always happened so that if not close to key there remained open, or sometimes ...

LM:

No, not at first, then started giving us problems around mid-October, we complained about this issue in which we had to lock the door.

GM:

Senta and the keys instead of the various rooms we had you all?

LM:

No, Romanelli had his room key, I, Meredith and Amanda we had.

GM:

Each of his room?

LM:

Yes, each its own room.

GM:

Then to Filomena remained open necessarily?

LM:

Yes.

GM:

I just wanted to know this, you're holding the rooms opened or closed, the doors to the rooms?

LM:

The kept always open except when we went away, Meredith when he went to England closed their room key-but only on that occasion. I also once going from my parents in Viterbo locked the door, but usually that's when we walked away for a long enough period, otherwise the left open.

GM:

In particular, Meredith was always open.

LM:

Always open.

GM:

Except ...

LM:

Except here ...

GM:

When she had to go away for a few days ...

LM:

Yes, go away for a long period.

GM:

Going abroad if I understand.

LM:

Clear, Yes.

GM:

And Amanda.

LM:

No, Amanda never enclosed it, left her open.

GM:

Look I wanted to know the relationship between Meredith and Amanda as they were, if I can describe it, if it were always the same, or if they have changed and in that sense. Me what each other, if they spoke with you if he spoke with you what he said the other, 1 ' one or the other, that I wanted to know.

LM:

In all honesty I wasn't getting much time at home because of practice I am doing, however the relationship between the girls I looked good in that they are of the girls who had a very close to each

other, both speaking English that I thought that the relationship between the girls was good, in any ways she never spoke of relations with any other.

GM:

There was some venting one of two on the other?

LM:

No.

GM:

Here's but these relations between the two have remained the same or at some point are somewhat changed?

LM:

Initially I noticed that • the girls came out more t empo ins ieme, sometimes you get anavano, went to the Center together, went out for walks together, then I saw that each had taken a bit more their own way, they were a bit away but without major rifts or without special reasons, each trying to make his own life, but I don't think there were problems among girls or at least I wasn't aware of.

GM:

Look her Raffaele Sollecito knew and when?

LM:

I met him about 10 days before the accident to Meredith, I don't remember exactly the day, remember I was back from work and exited the bathroom I saw this guy who was cooking in the kitchen and then I asked him who he was and showed up, told me that his name was Raffaele and I remember that was cooking the pasta about Amanda and later that day joined Meredith to have lunch with 1oro.

GM:

She remained there for lunch too?

LM:

No no, I had had lunch.

GM:

However remained in the House?

LM:

I was in a little house, time for a coffee and then I was able to return to study.

GM:

Know whether Meredith has been injured that day?

LM:

No no, I don't.

GM:

Look how many times he saw in the House tell Via della Pergola Raffaele? She said she saw him ten days earlier.

LM:

Yes.

GM:

She then tells us when it went off, but I mean how many times have you seen him?

LM:

Look I don't give details I think two or three times four, though I repeat not staying long at home and can not remember how many times I saw him, I'd say around-4 times.

GM:

Senta and at that time when she was in the House on Via della Pergola had met Raphael so that was ten days roughly a margin of time of ten days, she had remained there, everyone was there and she had met Raphael who occasionally came there to Via della Pergola if ...

LM:

Yes.

GM:

At that time Amanda was asleep in the House on Via della Pergola?

LM:

No, very often slept at the home of Raphael.

GM:

You remember roughly what days?

LM:

No.

GM:

Look but he said when he had to go from there, greeting Raffaele warned?

LM:

No, no.

GM:

And she as noticed that ...

LM:

Well, I realised why I noticed that there was his presence. It must be said that Amanda was very early, so the morning if she was in the House very often were having breakfast with me and Filomena so we realize it if he had slept at home or not and the rest was also a presence that he felt, a girl very jovial, which was a bit confusing, so we realize it if she was in the House or not.

GM:

At that time, how many times has stayed at the home of Raphael?

LM:

I can't tell.

GM:

He doesn't remember. Hear her when she saw Meredith modified?

LM:

I saw her on 31, at lunchtime.

GM:

Behold, what time then?

LM:

Towards the. 3, even before, the 3 was the last time I left the House to go to work and then I would have started at my parents House.

GM:

Here's what did Meredith?

LM:

I beg your pardon?

GM:

What did Meredith?

LM:

That day?

GM:

Yes, when she saw her.

LM:



She had risen, was having lunch, it was time for lunch.

GM:

She was alone or with someone?

LM:

She was alone.

GM:

Remember if there was Filomena?

LM:

No, I don't remember.

GM:

She recorded on November 2 said there was Filomena, as is a particular not relevant but in short anyway you stated that there was Filomena, who dined with Filomena, remember now, verbal November 2.

LM:

I tell the truth, I don't remember, but anyway with Filomena dined together-because — had the same hours of work.

GM:

Look then like Meredith was wearing that day?

LM:

I don't remember that.

GM:

Then she said hello to her, greeted everyone?

LM:

I said goodbye to ay girls.

GM:

And where did it go?

LM:

I went to work.

GM:

Law firm, she was going to a law firm?

LM:

Yes, the law firm of Attorney Orlando.

GM:

And when remained in the Chambers of Orlando?

LM:

I was I guess up to at 6 before setting off and go in Viterbo from my parents.

GM:

She watched, she went in the bathroom, in your bathroom, bigger one.

LM:

Yes.

GM:

There were two bathrooms in the House.

LM:

Yes.

GM:

You what you used?

LM:

We used the one adjoining the kitchen, bigger one. We, me and Filomena.

GM:

She looked if the bathroom was cleaned or if there were feces in the toilet?

LM:

No, the bathroom was clean.

GM:

Look so she then went to Viterbo.

LM:

Yes.

GM:

Who warned you and when Meredith's death?

LM:

Warned me the morning around noon and 2 40 Filomena, called me on the phone.

GM:

At noon and 40?

LM:

Yes.

GM:

You stated at 13.40, the minutes shall be on December 5 2007 if you want I can see.

LM:

Yes.

GM:

"the November 2 13.35, I received a call from Filomena, spoke very slowly," etc., then she said on December 5 that were 13.35 now can remember?

LM:

Yes.

GM:

That is, as he said so or you as today?

LM:

It's like I said then.

GM:

So was warned and what she said Filomena?

LM:

Filomena said that thief had come in the House and that they had killed Meredith.

GM:

Had killed Meredith. Feel you remember with what, what were the products of cleaning house, how many times did you do cleaning as you have Casino if there was a shift?

LM:

I don't recall products that we used for home and regarding housekeeping was a reason a little spat with the girls, it must be said that I am very precise in this respect, some almost fixed and girls is not that much to be cleaned, so it is true that I am the last days of October I had done, I had written a turn to housekeeping and had hung in the door in which even I expected some sort of fine of 5 Euros for those who had not complied with 10 round of pulizie and so most times I did it I or Filomena.

GM:

Behold, you or Filomena roughly what were you doing ...

LM:

Yes, most of us.

GM:

She remembers, then said he did not remember what products you used for the pulizia.

LM:

No.

GM:

Questions: you used bleach or lisoform?

LM:

No, not that, I'm sure.

GM:

In other words, it is sure that you used or ...

LM:

No, I don't.

GM:

Neither bleach nor lisoform.

LM:

No.

GM:

And she said some pulizie will generally charge you.

LM:

More Yes I and Filomena ...

GM:

When Amanda and Meredith can saw clean, in which situations?

LM:

Yes, sometimes Yes, rarely but yes.

GM:

And they used?

LM:

Broom, MOP, but products that we had were like, now I can't say the name exactly, but kind fabuloso, these liquid soaps, perfumed.

GM:

Senta remembers ... And where were the products that were there, with what you cleaned House, there were no MOP?

LM:

Yes, a MOP.

GM:

Where were these MOP?

LM:

One was in the garden, but clearly not used because it was filthy, full of leaves, often with animals too, and the other one was in the House behind a door, the door in the hallway that connected the girls ' rooms, Meredith and Amanda back there there was a Cabinet where we kept the MOP, broom and various products for cleaning.

GM:

Look before you go forward, remembers Amanda's room if there were no lamps?

LM:

Yes.

GM:

That there were no lamps?

LM:

There was a black with a red button abajour.

GM:

Senta and where he was, where was located?

LM:

He was on the nightstand of Amanda.

GM:

Senta and with regard to the power supply please note that foods preferred Meredith, what kind of ... What it purchased instead, she liked the mushrooms?

LM:

Yes, the mushrooms.

GM:

Then ate them often?

LM:

Yes

GM:

And you instead of you preferences? Amanda for example.

LM:

Amanda ate often mozzarella, tuna, tomatoes, these foods so fresh.

GM:

Remember if the boys arrived, or strange people in the House?

LG:

Strange does not fit.

LM:

Yes, some times came Amanda with a friend Yuva, especially at lunchtime, I saw this guy and he was a guy who worked with her at the bar, at the Pub The Chique.

GM:

There was someone else that accompanied Amanda sometime?

LM:

I couldn't tell, one morning I saw that Amanda was having breakfast with a boy named Daniel who was a friend of neighbors, but other guys I don't know--say, among other things I repeat we do not is that we were very much at home, so I do not know if ...

GM:

But remember the names of other women who have come from you, you remember how they entered, who brought them, who invited them?

LM:

No.

GM:

Her in December 2007 on 15 minutes, he doesn't remember the names?

LM:

No, I don't remember them.

GM:

Anyway do you remember this Daniel?

LM:

Yes.

GM:

Remember when I have breakfast with Amanda?

LM:

The day exactly no, I remember, I remember that 1 guys had gone dancing at Redzone and waking up one morning I noticed that Amanda was having breakfast with this guy.

GM:

Look but the names of some peace, Russian, some Clifford Panton?

LM:

These are my friends.

GM:

Look she has known Rudy Herman Guede?

LM:

I saw him on one occasion at home, I was down to greet them, it was Sunday and I remember that this guy was sitting in the room with the guys watching the Grand Prix, remember it was the last Sunday in which he ran the Ferrari but we said barely Hello because I remember this guy. ..

GM:

Roughly what time it was?

LM:

It was October, can't remember exactly which day it was. Remember it was the last day when he ran the Ferrari, won the Grand Prix.

GCM:

When you say home of boys who are you referring to?

LM:

The neighbors downstairs.

GM:

The neighbors downstairs. Senta vpi, there was among you who was using drugs?

LM:

Yes.

GM:

Well, if we can say ...

LM:

Sometimes it happened that we smoked in the House all of hashish on a couple of occasions.

GM:

Everyone?

LM:

Everybody.

GM:

In other words, even with the guys downstairs?

LM:

Yes.

GM:

The four of you and the boys downstairs?

LM:

Yes.

GM:

Do you remember when?

LM:

Also in October, but I couldn't point it out exactly.

GM:

Look but Rudy saw him only on that occasion?

LM:

Yes.

GM:



Listen please remember if she repeats saw Raphael about ten days before, then over a period of time, say ten "days in that arc" time please remember if Meredith went to Raphael's House?

LM:

No, I am not aware.

GM:

As getalong Meredith and Raffaele Sollecito?

LM:

I couldn't relate.

GM:

That is, they were familiar or you just says Hello, I mean there are so many ways, he must have known surely though I say was, saw them talking, or just greet you, this I wanted to know.

LM:

You will be spoken surely though I don't think there was a very strong bond between the boys, but clearly it will be spoken seeing Raphael is normal and then a few words exchanged, we exchanged.

GM:

Look you have ever seen in your home this knife shows? It's exhibit 3 6 that was shown, then hopefully I can produce even on this occasion.

GCM:

We have already acquired.

GM:

Yes, I have already acquired.

LM:

No, I've never seen him.

GM:

Never saw it. Hear when Raphael was home in Via della Pergola, you saw ... How many times you saw him, he told me about 3-4 times.

LM:

Yes.

GM:

On those occasions as comported with Amanda, who did?

LM:

It was very close to Amanda in the sense that I noticed that every step he took Amanda Raffaele was behind embracing it, coccolandola very affectionate towards Amanda.

GM:

Following her ever?

LM:

Yes.

GM:

Senta Amanda wreak with you, talking to you about his job, what he said, if he was satisfied, and if not satisfied? The various points of view.

LM:

Yes, sometimes spoke to us of their work and wasn't very happy because not being remunerated as he would have liked in the sense that despite was very present in the Pub the Chique wasn't being paid ...

GM:

Knows how much she took?

LM:

No.

GM:

Know what was Amanda's business hours?

LM:

I saw partirla almost every night at 9:30 and I don't know what time came because clearly I was asleep, but ...

GM:

Almost every night?

LM:

Most evenings Yes, however was very present at this pub, worked almost every time.

GM:

There was Let's say one day a week where wrong surely at the Pub The Chique?

LM:

I don't remember that.

GM:

Look so she receives on November 2, we go to 2 November, receives a call from Filomena at 13.35 about.

LM:

Yes.

GM:

What does he do?

LM:

I recalled other times around 5:30 am Filomena and then coming to Perugia with my father, my sister and my sister's boyfriend, I came to Perugia.

GM:

Then she came in Via della Pergola?

LM:

Yes.

GM:

Entry?

LM:

No.

GM:

Remained outside?

LM:

I went into the garden and there they stopped immediately, stopped me immediately the police asking me who I was and I replied that I was one of the girls lived there in that House, and then I went to the police station.

GM:

Senta and when he stood, when she arrived there were Raffaele and Amanda?

LM:

To The Police Station?

GM:

Even upon arrival ...

LM:

No, at the moment I arrived at home there was nobody, everybody had already been brought to the police station. I came last.

GM:

The police station instead?

LM:

Police remember that there were, Yes, Raphael, Amanda, there were all the friends of Meredith, Filomena, Marco Zahrani, Yes, they were all there in the waiting room.

GM:

I can describe the behaviour by all these people who were at police headquarters? Describe a bit.

LM:

Clearly we were all in shock, alarmed by what had happened and saw Amanda and Raffaele often get cuddle even in that circumstance, be many hugs, many kisses and this.

GM:

Feel you remember before we go any further, if Meredith's room or to another room, however there was any Vaseline?

LM:

No.

GM:

Wasn't there.

LM:

That I know not.

GM:

That you know so there was inside the apartment, but particularly in Meredith's room.

LM:

No, I don't know.

GM:

IE doesn't know, doesn't remember or doesn't seem so.

LM:

No, not really.

GM:

Look, you said you talked ... Amanda and Raffaele were talking amongst themselves?

LM:

Yes.

GM:

And they spoke with you too, IE did, they talked to each other and then spoke with you too, what did they say?

LM:

I wouldn't report it, we were all shocked by what had happened, but I don't know here is report what was said on that occasion.

GM:

Then she spoke on that occasion with Filomena?

LM:

Yes.

GM:

Filomena said something that had been reported by other people?

LM:

Well, they told me that day ... Yes, I said that Amanda had made the shower and although there were blood stains in the home, a behavior then and there it seemed a bit strange because we probably won't have a shower, we were alarmed to find blood stains at home. Yes, I remember this.

GM:

Look but Amanda was saying things that have struck the police station?

LM:

I don't remember.

GM:

I feel you on when the context if you don't remember, on 5 December 2007, page 15, should be, this is the record made in the prosecution, she says, "Amanda sometimes complained that the Gendarmerie was rather abrupt, saying that she was lying, surprised me in particular that she knew things, then I do not know the interrogations are clearly different from person to person I don't know the details that the police knew surprises asked if Meredith was sex, a detail that I remained a little, it seemed a bit strong. " Here's you remember?

LM:

Yes.

GM:

Now do you remember?

LM:

Yes, I remember that.

GM:

So it's like or as. ..

LM:

Is that so.

GM:

Try to remember again ... There were other things ...

LM:

This thing I can't remember now but not reported heard exactly that day to the police station, he heard her several days later from Amanda that Yes I remember that ... Behold, it struck me that he knew few details if Meredith had done Analsex or ... That to me seemed a bit strong quite honestly because I was not aware of these things, but as reported in the condition I thought maybe every interrogation is stand alone, each referring to things though it seemed to me that Yes knew, referring to details that we don't know about.

GM:

There were no other details besides that which you didn't know, you reported?

LM:

He reported the presence of petroleum jelly in the House, which we did not know.

GM:

When he said this?

LM:

Always on that occasion, I remember it was a Sunday.

GM:

So if it was Sunday was supposed to be 4?

LM:

Yes.

GM:

Because the 2 was Friday, I remember it well. Then Sunday, 4 where were you?

LM:

We were home by Maurizio Pace that was a guy that I was hosting.

GM:

So sorry let me understand, at that time why she came here, Amanda?

LM:

Because that day we met with Amanda, Raffaele, Filomena and Marco a little to talk about, to feel a bit like we were, because clearly we were all shocked a little to make us force each other say and everyone spoke of the things that were happening, Amanda told us that the police were particularly pressing against it and told us these details.

GM:

But I wanted to know this: the fact that she said the police asked if Meredith was sex, i.e. it is not a statement, she said that as a question which has been directed by the police, that's what I understand. In other words, this is not what you say, I know you did, etc., no, she said the police asked if Meredith does sex, is it?

LM:

Yes.

GM:

Detail of Vaseline that was in the House the reported in the same way, i.e. police said told me there was petroleum jelly or said so?

LM:

Look in all honesty I don't remember because then that day Amanda speak much English and I had a bit of trouble understand it right, remember here and said this particular vaseline, but now exactly the context in which ...

GM:

Here, however, said there was petroleum jelly?

LM:

Yes.

GM:

Do you understand English?

LM:

Pretty good, Yes.

GM:

Remember how was the phrase that ...

LM:

No, I don't remember.

GM:

Hear another thing, when you were in headquarters someone of those present, everyone has talked about the fact that Meredith could have suffered a sexual assault and that she screamed, he screamed?

LM:

I don't remember that.

GM:

IE not remember or think not?

LM:

I don't remember exactly, I couldn't respond.

GM:

Hear another thing, remember what clothes, all the clothes i had Amanda to take at the end of October?

LM:

No, I just remember how she was dressed on 2, had a white skirt, a magi ion ino blue but no.»

GM:

So you don't remember what clothes could have Amanda, I don't know, coats?

LM:

Often Yes remember only one thing that was a gray sweatshirt with hood and remember why she sent her boyfriend from America and put this sweatshirt.

GM:

But it's not that she — She saw every day Amanda?

LM:

Yes.

GM:

But saw her out as she was dressed when going out?



LM:

I saw her in the House, but was already dressed, but ...

GM:

No, when you put something, a coat for example.

LM:

No.

GM:

You haven't seen her, had not seen her. Saw her at home without, as she was in the House?

LM:

Yes.

GM:

Hear something else, she saw if Amanda had any injury, some scratches, some wound?

LM:

I realized that day that Amanda had a wound in the neck and I noticed that when I was in the police station it was known that I mean Meredith had died due to a neck injury I impressed me so much, I was very keen to see how the same Amanda, I was very worried about her because I had no idea that she was a girl her off home so I was very worried about her and realized that she had this scratch in the neck and Yes I noticed this.

GM:

Look could be something related to sexual relations?

LM:

No, I didn't.

GM:

This scratch, she named, he had it on 31 when she saw her for the last time?

LM:

No, I don't remember.

GM:

I'd like to produce, whether it is this, if you can tell then wonder to produce this ... If it was quésto the scratch that she saw.

GCM:

The parties know this ... We can also see at parties.

LG:

Black and white photos, even the knife, not help to understand, understand, it will be necessary to produce the color photo, as was done for the sweatshirt ...

GCM:

Yes, however that photo we gained.

LG:

But here you don't see anything.

GCM:

Okay, so this is what the Prosecutor asks to submit to this end, we are.

CDV:

The public prosecutor can you tell us the date of this photograph? That is when this photograph was taken?

GM:

He got the dottar Lalli. It is recognized on the record that was made the day of the inspection staff who then corresponds to 6 November.

GCM:

We can show to the test, and then the photo.

LM:

I saw her.

GCM:

And then?

LM:

Yes, coincides with what I've seen, with the scratch that had 2.

GM:

And he had no 31?

LM:

No.

GCM:

Sorry, but this maybe if he could complete, 31 she recalls how she was dressed Amanda if she had?

LM:

Had a white skirt and a blue sweater in "V".

GCM:

And then left uncovered.

LM:

Left uncovered necks Yes it showed.

GM:

Sorry, she's seen her, the first time you saw "Amanda on 2, his neck was discovered or had the scarf?

LM:

The 2?

GM:

The 2.

LM:

His neck was discovered.

GM:

At police headquarters, IE I wanted to say if she saw her off if she was with the scarf?

LM:

I saw her to the police station because I arrived later than everyone, yes it was a neck uncovered.

GM:

I have no further questions.

GCM:

The civil parties if there are questions. No questions. Defendants ' defenses.

Defense-AVV. Rocchi

DR:

As for when she came to know Meredith's death we can report exactly the words he used Filomena?

LM:

Filomena told me that, I don't remember his exact words, precise, though she told me she had entered thieves in the House and that Meredith had been killed.

DR:

I repeated several times?

LM:

No.

DR:

Then I have to dispute what she reported on 5 December 2007, she says: "Yes, at the 2 November at 13.35 got the call of Filomena, spoke very slowly and with a very low voice so much that I was in the middle of the road and I couldn't hear well and told me he had entered thieves in the House and that they had killed Meredith and of course I'm not there I believed so I have asked Perry repeat ".

LM:

Yes, I asked him of course, but her before I recited, because I told her "Filomena but you are saying, are you kidding?" and she has repeated the same things.

DR:

That is, he said: "but you say, repeat" and Filomena repeated to me "look they entered the thieves in the House, they killed Meredith" and that this is how I heard about the death.

LM:

Yes.

DR:

Instead regarding bleach she excluded that at home you used bleach.

LM:

Yes.

DR:

The show that was recently purchased by Filomena bleach?

LM:

No, I am not aware.

DR:

I owe you contest then than she reported in the minutes of the November 15, question answers "Of usual home we cleaned anymore and Filomena that other, we used a product of a heavenly bottle can't remember his name, except that it may be bleach or Lisoform. Recently Filomena had bought bleach can't remember the packaging, but we paid only a little in the toilet of the bathroom, "he told her.

LM:

I don't remember.

DR:

She can't remember.

GCM:

Now remember?

LM:

No, I don't remember.

GCM:

Though these are statements by?

DR:

Of 15 November.

GCM:

Then she on that occasion was telling the truth, that he remembered.

LM:

Of course.

DR:

If I can then ask for the acquisition of these minutes for these statements.

GCM:

Yes, there is the consent of all parties, he used for the protest, but we feel the public prosecutor and other parts that might be.

DR:

Instead we can report exactly, already told us something, on reports that there were between Amanda and Raffaele, how can define them? Had them fully defined on one occasion, that is what they did when they were together.

LM:

Well, it's about a couple who clearly demonstrated during the first few days, you showed great affection, were continually embraced each other, sweethearts, say, especially remember Raphael who was especially tender, to me sometimes seemed almost a little possessive, to me at least it would bother me, very attached to Amanda.

DR:

Then like two lovebirds?

LM:

Yes.

DR:

Look and instead I wanted to ask whether the 7 May and April she remembers if you have felt alone when he made statements.

LM:

I don't remember that.

DR:

Has not been felt along with Filomena?

LM:

No, I don't remember.

DR:

Then I ask these two verbal and verbal are cumulative in the sense that we can say that Miss Mezzetti was heard together with Romanelli Filomena.

GCM:

This is the minutes of the meeting?

DR:

Minutes of the May 7 and 11 April 2008.

MC:

It seems to me that had already been produced.

DR:

Yes, were produced, I ask anyway ...

GCM:

As historical fact you ...

DR:

As historical fact.

GCM:

And 1 other verbal instead calls for the acquisition, the other on bleach she used for the purposes of usability.

DR:

For the purposes of usability of that part, is it possible?

GCM:

That part made it contested and then confirmed the point and said it as well as she had stated that if asked to produce it for the purposes of usability of entire statements. On that at the end of the examination of the heads maybe do a summary of the productions which are presented for the acquisition of which it will be evaluated and you will decide. I pray the lawyer Curt.

Defense-AVV. Curt

MB:

Let's go right at 3 0 June, then two days before I, do you remember if you spent the afternoon together with Meredith and Amanda's case?

LM:

No, I remember, I remember the night we walked out I, Filomena and Meredith, but the afternoon do not remember it.

MB:

Note in the minutes of the April 11 that she made along with Filomena Romanelli, there are two of you to declare, spoken just the afternoon where, talk about the rent, of betrayal, of many things and Yes remember now?

LM:

Yes, I remember.

MB:

Can you tell us what happened that afternoon, until now you've been together?

LM:

It wasn't exactly the afternoon, it was lunch time, why I didn't remember, and remember there was Amanda who was, was particularly depressed that she felt a bit guilty towards the American boyfriend because he said that he loved him, but at the same time was very taken by Raphael that we talked a bit of betrayal in General and said "Okay though, we tried a little to cheer her up.

MB:

Perfect anyway ... No no, sorry.

GCM:

You are welcome.

LM:

We tried a bit of cheer, remember that Meredith was the one who showed their opposition to the betrayal, said that she had never betrayed in her life, that was one thing I particularly disliked and then at the end of the debate, however, we said that you had to pay the rent within the first of the following month and then we invited the girls to withdraw money , to withdraw and Meredith told us that he had already collected the rent money and who had in the House, I remember this conversation.

MB:

Yes, here you say "we want to both add spontaneously something that we had never reported that on October 30 early afternoon" and then this one ...

LM:

Yes.

MB:

Can you tell us at what time you been together?

LM:

Are the 3 and a half hours, 3, because I then towards that now, both myself and Filomena we walked away to return to study.

MB:

And you know after what were the programs of the two girls?

LM:

No.

MB:

You don't know if they were to meet someone, if they were to go to college or something?

LM:

No, I don't know.

MB:

I knew that day there were no other people or they were waiting for someone at home?

LM:

I couldn't tell you.

MB:

She can't remember.

LM:

No, we were four of us on that occasion, but if then expected someone I don't know.

MB:

You have talked about anyway?

LM:



No.

MB:

One more thing, how come this cumulative report was done between you two, there was some problem in the Office or you have asked to be heard together or what?

LM:

I don't remember why.

GM:

There is opposition to this question.

MB:

Opposition why apologize?

GCM:

If she was, it turns out.

MB:

I ask this because is not usual in fact.

GCM:

Please let us Attorney evaluations we only do the questions.

GM:

We will ask the Police why anyway.

MB:

Definitely ask.

GCM:

Please Counselor.

MB:

Always the 3 0 then you exit the evening told me, you remember who you were?

LM:

There was me and Filomena and then we reached Meredith with other English girls, we go to Tana dell'Orso because it got a concert a guy who was a forensic school with me that sometimes he taught me to play guitar and then we went to hear this concert.

MB:

Amanda was there?

LM:

No, there wasn't.

MB:

Remember if Amanda, if we say between her clothing, had a red coat?

LM:

No, I don't remember.

MB:

And as for the drying rack that you had in the House, it was common to all or you had more?

LM:

No, it was common to all the girls.

MB:

In other words, it was a single one and using them all?

LM:

Yes.

MB:

Regarding his attendance with Amanda and Meredith I seemed to understand it was not very busy, say if I understand correctly, if not correct me.

LM:

Some times we go, on two occasions I think I remember that we went out to dinner together, but also having different interests and different ages is not that we did hang out a lot.

MB:

Perfect, that's the whole point, so when you said I do not know that Meredith has ever went to Raphael, that is, it says in the sense that the results but it cannot exclude or you sure didn't go?

LM:

I'm sure because I believe I would report Meredith as meaning at least these things I went for lunch from this man or the other, we talked in sum.

MB:

But since he says you have a vine tomatoes several, separated.

LM:

Yes of course.

MB:

She is able to tell all the people who attended, even your own home in your absence, friends, their friends or their girlfriends, of course.

LM:

Meredith basically attending girls, I've never heard tell kids or other people, I always watch four or five English girls, was always with them.

MB:

I say this because in the minutes of 15 January 2008 on page 2 says "Preciso me that Filomena were home very little so we can't tell who actually attend our House in our absence," was this so why.

LM:

Yes Yes, I confirm that actually we were out most of the day to practice, we were both in studio, but here goes.

MB:

Let's go to the point Rudy Guede, her quant and you you and if she saw him and how many times he saw and where?

LM:

I reported before, I saw him on one occasion in the House of the neighbors downstairs, it was a Sunday and I've seen for 10 minutes the time when I went to say hi to the guys.

MB:

Who was there besides the guys below, if there was someone else? There was only Rudy and the boys downstairs or was anyone else?

LM:

No, there was Rudy and kids under recall.

MB:

When you say that you were gone, to dance, namely those who had gone to dance for what you know of course?

LM:

I remember once they came some friends of neighbors, in particular remember Daniel e. ~ were several guys.

MB:

Were we say not of your apartment, that had gone out dancing Rudy with the guys and other people, not with you.

LM:

No, I don't think there was Rudy anyway I can't certify because I wasn't there that night, there were the neighbors with the others, I remember (voices).

MB:

I understand, then ask your neighbors.

MB:

Another thing, has already reported earlier on the phone call about the phone call exchanged with Filomena on the day of the discovery of the corpse, she said that has warned at 13.35 of uh theft and murder, so he never talked about Filomena simulation of offence or else, spoke only of theft at the time.

LM:

Yes.

MB:

Remember when you were in the police station if Raphael said something about the murder?

LM:

No, I don't remember.

MB:

We go to scratch, scratch issue, I see that you have already reported on 2 November 2007, December 2007, 15 November 5, 11 April 2008, may 6 2008 7 November 2008 and finally. So let's say the sixth attempt so remember that scratch, I wonder why ...

GCM:

Maybe you can resume the question ...

FM:

Yes, but the question is formulated without comments because it influences the heads ...

GCM:

Pardon attorney, please speak ... We avoid these dialogues between the parties, says lawyer. Wait before responding and we see, since there is the foreshadowing perhaps of an opposition.

MB:

Then I said that was heard 6 times, only in the sixth report speaks of that scratch.

FM:

There is no opposition.

GCM:

Please let the question lawyer.

FM:

Sorry there is no opposition, I would verbalize the opposition.

GCM:

In fact we're recording then is automatically printed, though Lawyer do the question.

MB:

Can I directly the question, why hadn't talked before, I talked about the November 6 2 0 08 and did not mention it before, how come?

LM:

I've talked about it before because I thought that scratch was apparent to all, as I noticed me, me that day I noticed immediately, I repeat, precisely because of the fact that Meredith had been killed with a cut to the throat that I noticed that scratch of Amanda and I reported it because I was convinced that they had noticed everyone. Then I know that Stephen Baldwin, one of the guys who lived downstairs, he was called during 1 ' preliminary hearing to testify at that time spoke with 1 ' Inspector Napoleons which reported that scratch that I had noticed on the neck by Amanda, whereupon I have called sgridandomi agents because ... Tell me how did not report this scratch and I have called to report this circumstance, reporting that I to 2 realise this scratch. Behold, if maybe I reported it right away is because ...

GCM:

But the 2 she had already talked to someone else of the guys who had seen that scratch?

LM:

No no, this I spoke later with Stephen because he is engaged to a girl of my own country and one day returning by car. ...

GCM:

That day we, when are you talking about?

LM:

I don't remember him Presidente, I don't remember.

GCM:

Then talk with this guy who she had seen that scratch ...

LM:

This scratch and he refers to the provincial Napoleons before testify during a preliminary hearing, at which 1 ' Inspector calls me back and told me if it was true that scratch thing, I said, "Yes, that's right, I didn't notice," and then I was called up to report this condition.

GCM:

You are welcome.

MB:

Yes, but you of this condition had talked to the other guys, I say ...

LM:

I had talked with Stefano.

MB:

But when?

LM:

Once while walked back to the car together in Montefiascone, I don't know how it came out the speech, in all honesty I don't remember clearly when we see, we meet with the neighbors often comes out this speech because alas binds us all and therefore we often talk about this ...

MB:

Therefore neither with English girls, nor with Filomena, nor with others, i.e. only with Stephen talked about it?

LM:

I spoke to Stephen Yes.

MB:

Are you sure the 31 October didn't that scratch? I mean surely you saw the day you saw him, but the 31, told me that he saw, 2 ...

MC:

No, he didn't have the 31 ...

MB:

Sorry to get this answer.

GCM:

Sorry Lawyer, has already been answered.

MC:

The examination does not mean reword the same questions.

MB:

No no, it's not the same.

GCM:

You confirm that the 31 didn't have one?

LM:

Yes, he didn't have.

GCM:

And she the 31 has got to see Amanda Knox ...

LM:

Yes, however throughout the day it happened that I always watch the morning yes, didn't have one.

GCM:

You can say until 31 saw her, that is the last time I saw 31 if you remember.

LM:

In the morning he didn't have.

GCM:

And as she was dressed in the morning?

LM:

I don't remember.

GCM:

His neck was uncovered or covered in short when you saw it? I.e. the scratch in place which saw him on November 2 he could see and meet Amanda Knox on the occasion of 31? That is, maybe you saw it had a scarf on the neck ...

LM:

I still met inside, to whose house is not that we were with scarves or blankets.

MB:

So then the 31, after the morning and I didn't see Amanda was my question. The 31 say after late morning and all I with Amanda you haven't seen them?

LM:

No, I went to Montefiascone so I wasn't there.

GCM:

Yes, he already reported before, please lawyer.

MB:

The last question about simply the vaseline, you said exactly that remember not sight unseen, but in a sense, be sure that there was, in the sense that they talked with roommates or simply never saw it or believes that there was?

LM:

I honestly never seen let alone we have never talked about these things, but seeing, i.e. knowing Meredith in short it seems strange that there was petroleum jelly in the House, but ...

MB:

For many uses, it's not that we use ...

LM:

But for heaven's sake; absolutely but it seems that there was, much less ...

GCM:

Nor have you ever spoken?

LM:

No, we never talked.

MB:

I'm done thanks.

GCM:

There are other questions.

Defense-AVV. Ghirga

LG:

She last saw Amanda when compared to the fact?

LM:

On the morning of 31.

LG:

But in what condition?

LM:

We met at breakfast because Amanda as I said before was very early morning, he woke up early, so it happened that we ate breakfast together.

LG:



Because until today is that for what concerns the ..., she had seen Amanda on 30 afternoon in those talks to four you do her, Amanda, Filomena and Meredith on cheating and something else and she said before that afternoon, he talked about a lot, look at the President.

GCM:

Yes, you keep looking at the microphone.

LM:

I beg your pardon.

LG:

He spoke of ... When you see this sign you by Amanda?

LM:

This sign of Amanda I see the 2, to the police station.

LG:

He sees the 2 police station and had not the 31?

LM:

No.

LG:

But by other measures then I read, she saw the last 31 30 Amanda, I asked under what circumstances, she said. I don't know, its focus was crystallized in the November 20 07 directness in a direct conversation on 30 31 October and 31 October, not August she reports that at lunchtime sees Meredith and Filomena ...

FM:

President there is opposition, I would demand not a premise.

LG:

The question is when was the last time you saw Amanda before the evening at police headquarters, said the 31 morning.

LM:

I seem to recall I repeat ...

GCM:

Yes, you have already said on 31, may clarify the 31 what was? Had breakfast?

LM:

Had breakfast, I remember ...

GCM:

What time do you remember?

LM:

The location we had around 8 in the morning.

GCM:

And her after breakfast leave the House?

LM:

After breakfast I taking a shower, I was getting ready and to ...

GCM:

What time?

LM:

And from the 8 and three-quarters, 9, I left the House to return the one and a quarter, at 20.

GCM:

After day this opportunity she sees Amanda Knox at the police headquarters.

LM:

I see her on 2.

GCM:

Behold, the 2 police station.

LM:

On 2 November.

GCM:

The last time, this called for the Lawyer, sees the 31 morning on this occasion.

LM:

Yes.

GCM:

She remembers how she was dressed on 31 morning?

LM:

No, I don't remember.

GCM:

In pajamas, as was ...

LM:

I don't remember. No, anyway when I saw Amanda was always dressed, it was never in my pajamas, but I don't recall that he wore dresses, I don't remember.

GCM:

Please Counselor.

LG:

I will however in the light of the foregoing statements, verbal and then ask you to produce emerges only today that saw the 31 morning ...

GCM:

In short, the evidence is formed in a hearing and then we ...

LG:

Certainly that is formed in the main hearing.

GCM:

Please Counselor.

LG:

Now I'm with the permission of the President and of the parts show the two color photos instead of this scratch that calls her and this is assessment for which we take note, there will be other ways to ascertain the nature, and of 2 November and 6 November, because Dr. Mak when on 6 August is called the police ...

GCM:

Yes, maybe if we make the question lawyer. The question what is? The photos show?

LG:

No, you must excuse me, why did they give you a black and white photo that you can not see anything.

FM:

President the question if there is no opposition to each question.

GCM:

Please, the photo is in black and white ...

LG:

No, I demand to be able to show the witness the two photos of Amanda a of 2 November and one of 6 November as the Prosecutor taken during cavity search from Dr. Lalli, can I?

GCM:

Yes, we do see the pictures and the question.

LG:

On November 2, I was interrupted I am sorry, Dr Mak, is the question: isn't that the November 8 20 08 after the decree ordering \_ judgment in that deposition he does on that scratch she says she recognized ...

FM:

No, opposition President, should ask the question, it cannot report a verbal ...

GCM:

Sorry maybe we do Advocate the question if the answer does not ...

LG:

You referred to the picture of Amanda on 2 November 2007 in the garden in front of the cas to look for a sign that takes off the internet? And I produce pictures. The exhibit. The question is this.

GCM:

We haven't yet understood, we understood that only wants to show to the heads of the photos, on these photos what ...

LG:

There are two photos, Dr. Mak the 8 November 2008 after the trial of the accused, shows up at the police station and about a scratch that she finds on the internet by Amanda on 2 November in the garden ...

FM:

But it is not so, but because it reads the minutes before the application was made President, is not the way.

LG:

The question is: is it true that you have seen the picture of Amanda on 2 November's internet?

GCM:

This is a question and we can ask, though we do the questions. Then she saw the photo?

LM:

The scratch I remembered, then to the police station I said that scratch, that scratch the throat was also featured in a photo, you could see clearly even from a photo on the internet of the day 2, but it's not that I looked at before the pictures and then I said "Oh yes," I remembered that scratch ...

GCM:

She saw then in internet a photo ... She has the photo Attorney?

LG:

Certainly, but her at police headquarters that picture you saw, this is the second question.

GCM:

Sorry, to the police station she saw a few photos?

LM:

To the police station I did watch the cops a pictures that portrayed Amanda and Raffaele from which it was possible to infer this scratches.

GCM:

Sorry, you say I did see this picture already.

LM:

I showed up and there was on the internet so we opened the internet and we ...

GCM:

The police station have open internet ...

LM:

Yes, I did see and I said, "look, moreover, that scratch you see even from a photo of Amanda and Raffaele" and there I opened it I.

GCM:

Understood. So much to rebuild she had seen on the internet this picture showing this scratch, this sign around her neck?

LM:

Yes, we saw it.

GCM:

Goes to the police station and says he saw himself on the internet.

LM:

Yes, you could see it on the internet.

GCM:

And at that moment she opened the internet and tracked down this picture.

LM:

Yes.

LG:

We can see if it is this?

GCM:

Sure, sure. Therefore shows this picture, that is the question what is on this picture? Is this the picture?

LM:

Yes, it is this.

GCM:

Where you see the scratch his neck. We Advocate, agreed. Is this the picture. Other parts ...

LG:

They have it.

GCM:

Yes Yes, of course they do, ima pictures. The parties know, Yes.

LG:

Secondly, she saw another picture of 6 November at police headquarters?

GCM:

With reference to this scratch.

LG:

Surely.

GCM:

With reference to this scratch her police station also saw another picture, if you remember.

LM:

They showed me the photos I've seen before in black and white, Yes.

GCM:

Showed a photo in black and white or colour?

LM:

No, there was color, same photo that ...

GCM:

We can see? This is the photo that showed in color?

LM:

Yes.

GCM:

These photos are produced Lawyer, calls the production?

LG:

Yes, yes.

GCM:

This is the picture, Yes. Then the outcome maybe we provides these two photos, even reread them together with the testimony of ...

FM:

We can verbalize, I apologize, Dr. Lalli, colored is is right? We complete the thought.

LG:

I didn't understand the question I.

GCM:

No, it's not a question, it's a clarification.

FM:

Is a clarification. Because otherwise it points out halfway and not good, we clarify everything.

GCM:

However is a picture or give a discharge, we do not know if is that of Dr. Lalli, when we'll show it to him and we'll see if Dr. Lalli is the one, that is.

LG:

Excuse me President, I didn't understand the question, because these pictures I extracted from the documents of the public prosecutor in genuine copy. No, because it says to those who are ...

GCM:

No no, it was just a clarification. Excuse me please, let's avoid such moments that don't need them. If there are other questions we put to the witness that we have here in front of you.

LG:

On the condition of the so-called scratch I finished.

GCM:

You are welcome.

LG:

Look, the fact is, the Vaseline because she learns in the days after November 2 when you meet someone at a friend's House that housed?

LM:

Yes.

LG:

Be sure that the condition of petroleum jelly was reported by Amanda Knox in the evening?

LM:

Yes, I told Amanda.

GCM:

Yes, he has spoken of before, Sunday 4 November said the occasion.

LM:

Yes.

GCM:

Please Counselor.

LG:

We heard other witnesses.

GCM:

Please Counselor.

LG:

He said it should be remembered that the sentence on uttered by Amanda, she said yes, turns out differently. Look she has a red coat?

LM:

I?

LG:

Yes, at the material time, in November 2007.

LM:

No.

LG:

I wanted to know this: she has never returned to Via della Pergola after ... You say the afternoon back from Montefiascone, goes on Via della Pergola then take her to the police station.



LM:

Yes.

LG:

After 2 November ever come back in Via della Pergola?

LM:

Yes, I returned twice once with the police because we had to check that the mancass not and nothing and and real f i care as was the apartment and \_ one more time that I was in the garden, was on 18 December and on that occasion we returned some belongings.

LG:

If I say that the first time is on November 4 because I gather from a verbal, you remember this date?

LM:

Yes.

LG:

Remember if you go with the Inspector Gubbins and Napoleons?

LM:

Yes.

LG:

When the verbalizzò this access you, remember? When he made statements on this access of 4.

LM:

No, I don't remember.

LG:

November 15, and wonder to produce minutes of summary information. What did you, Inspector Gubbins and Dr. Napoleons, what did you remember?

LM:

Before entering the House made us put things for repairing shoes, gloves, we entered the House, they made me check my house saying what was changed and I noticed that was open, was left open an underwear drawer in my room and were moved to the guitars, the agents I reported that ...

GCM:

They were moved?

LM:

The guitars, guitars that were in my room because I remember exactly how I had left my home, then I was told that those things had moved them and we used items in the kitchen, we did see, we had to check the knives in the kitchen.

LG:

By the way, I am finishing ...

GCM:

Excuse me, she watched the whole flat or just these two environments?

LM:

No no, I walked into my room and just remained stationary in the kitchen, there were made ... In the rooms where they stood them in the slightest.

GCM:

Well, please look to complete this lawyer.

LG:

I came to the knives, she uses an expression on page 5 ... How many knives you had at home and how they were distributed in the kitchen?

LM:

So we had many and I know this because when I entered the House I had care of clean all dishes and replace the knives, those that we used we were black and blue and I had put away other celestial and big in the drawer, were stored as well, so we used them always ...

LG:

Then in. .. Sorry, I thought he was done, sorry.

LM:

Those that we always were in the sink, Cutlery tray and repeat were blue and many others, and many other celestial cutlery was placed in the second drawer.

LG:

So many knives are distributed in the sink, in the second drawer, to frequent use if I understand it and in the bottom drawer as we learned, there were so many black, black-handled knife as you say?

LM:

Yes, but we had knives in the House with the black handle, were all with saws to cut the meat.

LG:

There were knives that you used, not in the bottom drawer.

LM:

Yes there were knives ...

LG:

There were no knives that you used?

LM:

There were no knives that don't we used, Yes.

LG:

And she from that black and white photocopy preclude a knife with the black handle of that type has been in the bottom drawer?

LM:

No, I'm the one in the House I never saw because those who were kept in the bottom drawer were still very large knives to cut meat.

LG:

This was. For now no questions.

Defense-AVV. The Widow

CDV:

I wanted first of all to clarify the facts about thunderstorms were coming to the House, then I'll make other requests for clarification. She said today that she got the call at 12.40 tell Filomena, then also said that because the record is at 13.35, this should be the correct time, you remember what she said Filomena, the first phone call, what did he say to you?

LM:

Repeat Lawyer who said they had entered thieves in the House and had ucciso Meredith.

Intervention-(off microphone).

CDV:

No, I asked for clarification. It is not the same question, I'm sorry, I made a premise, I said: "I want clarification on statements that he made before, if you please could you clarify what was the content of the call of minutes 12.40 Filomena or 13.35".

GCM:

Has already stated anyway in disputing a Prosecutor that the call took place at 13.35.

CDV:

The question was not the one, the question was what said Filomena.

GCM:

Yes, well both things, and what did Filomena Romanelli.

LM:

To me said she had entered the people in the House, thieves in the House and had killed Meredith.

CDV:

Had killed Meredith, has also told how they had killed Meredith?

LM:

No.

CDV:

She asked if ...

LM:

No, not ...

CDV:

Asked who did it? That reaction had this phone call?

LM:

I then and there I said to Filomena "Filomena don't tease me, you are saying". And Filomena said, "Laura again who entered thieves in the House and killed Meredith".

CDV:

Philomena told her where he was?

LM:

No.

CDV:

She asked him, "where are you now when you're calling? Where will you call me? "

LM:

No, I didn't ask because I was shocked, then I called later and I asked where it was, told me she was in the House, that some things in her room there was no lack of subjects despite the room had been ransacked, but everyone was there, there were jewels, there was the computer, though there no, in the first phone call I asked nothing.

GCM:

She recalled what time?

LM:

I don't remember, so for an hour or so, maybe even less.

CDV:

Then she takes the car and goes to Perugia?

LM:

Yes.

CDV:

Alone?

LM:

No, he walked me to my father, my sister and my sister's fiancé.

CDV:

And reach Via Pergola?

LM:

Yes.

CDV:

And she said that the boys were gone?

LM:

No, there were police.

CDV:

Then he goes to the police station?

LM:

Yes.

CDV:

Excuse me, if maybe ...

GCM:

No, please

CDV:

Maybe I will repeat ...

GCM:

Yes, we had already reported this, arrives at the House, police say "what you come to do" so, anyway let.

CDV:

And until now has remained then to the police station?

LM:

Up at 6 o'clock in the morning.

CDV:

But she returned to the House?

GCM:

When he says in house Lawyer refers ...

CDV:

House in Via Pergola?

LM:

No, I got home on Sunday together with the police to check the condition of the House.

GCM:

He already responding.

CDV:

On that occasion they asked her to check the washer?

LM:

No. They asked us if we had done the washing machine, but the bathrooms we entered, no, I don't know, I don't remember lawyer.

CDV:

Those who wondered if you did the washing machine remember?

LM:

No, the police asked us if we had done the washing machine or me and Filomena, but we didn't make it, so don't ...

CDV:

They also see the washing machine or clothes?

LM:

No.

CDV:

Even on other occasions?

LM:

No.

CDV:

She had a laptop, a computer?

LM:

Yes.

CDV:

And where he had it with him?

LM:

No, I had it placed in the desk in my room.

CDV:

And he remained there?

LM:

It remained there until 18 December when me 1 ' returned Yes, along with the other objects, clothes and shoes that were left in the House.

CDV:

She did an instance to have these goods back?

LM:

Yes.

CDV:

Asked a written request?

LM:

Yes.

CDV:

The computer you know if was analyzed by the post, his computer Forensic or guess.

LM:

I don't know a lawyer, I would say no, but I don't know.

CDV:

The computer wasn't working?

LM:

Yes.

CDV:

Look after you met Amanda on Sundays, 4, and reported the issue of petroleum jelly and sex, we have heard before. My question is: do you remember if Amanda told her that they asked, referring to the fact that she had been questioned and then to the authorities, they asked me if I had sex or if there was petroleum jelly or ...

LM:

Watch Lawyer I in all honesty I don't really remember how was this discussion because as I anticipated before the discussion was carried out in English, Amanda was a little a bit bored, tired of continual coming and going to the police station, I remember there was talk on that occasion of Vaseline and sex but I don't remember exactly what terms such as went out I mean this speech. I remained, I repeat that I was a bit perplexed because it had come out of these things, let alone the police had reported anything about it, but I couldn't tell exactly what words came out these arguments.

GCM:

Who you were on this occasion?

LM:

There was me, Filomena, Marco Zahrani, Amanda and Raffaele.

GCM:

With in particular \_ Amanda in guest to the occasion, she says she spoke in English, who he was talking to? He spoke with everyone?

LM:

With all of us.

GCM:

So all you got to talk about what ...

LM:

Yes, yes.

GCM:

It's not that she was speaking about these issues with someone in particular?

LM:



No, no.

GCM:

You were together?

LM:

We were talking, behold, at that time we met we talked about all of the impressions we had had, as we were, how we were reacting to the event, and she said this information.

GCM:

Here, talking about these two pieces of information in particular in which the Defender now asks her, do you remember if someone demanded an explanation further in this regard, I speak of these two arguments, if started in particular either?

LM:

I don't remember.

GCM:

Churches more explanation? Appeared particularly interested in these circumstances?

LM:

No, no.

GCM:

Don't know how to say. She recalls these two conditions called ...

LM:

Exact.

GCM:

Please Counselor.

CDV:

Who was present that morning, there was for example Prompt?

GCM:

That morning, sorry lawyer?

CDV:

Of 4, we're talking about on Sunday night, when she, still 4 day 4.

GCM:

He said, are their five I think.

CDV:

There was prompt as well?

LM:

Yes.

GCM:

He said it now.

CDV:

And she spoke with both?

LM:

Yes, they were discussions in which we were all present.

CDV:

In Italian and in English?

LM:

Yes.

CDV:

With Amanda spoke in English?

LM:

Yes.

CDV:

I got it, thanks. Hear only a clarification of the issue of the rent she reported that Meredith was ready to pay rent, just pulled out the money and made them see?

LM:

No, she said, she told us if we wanted the money, said "I got it at home, if you want I'll do" and both Filomena said "is not necessary because we don't pay them today."

CDV:

She saw the bag with the money or your wallet?

LM:

No, I didn't see, but Meredith told me he had already picked up the money and they were at home and if we ...

CDV:

Look, you said that you had a washing machine, you had also a asciugatore?

LM:

No.

CDV:

And then asciugavate on a drying rack?

LM:

Yes.

CDV:

On the drying rack you put the clothes tell more girls together, it happened?

LM:

Yes.

CDV:

Also one over 1? It could have been even that doing the washing machine together.

LM:

Usually I mean put ... On top of one another not because they wouldn't have even dried well, accommodated in the drying rack but not on top of one another.

CDV:

Look, you said you do practice of law by a lawyer?

LM:

Yes.

CDV:

Even now?

LM:

Yes, I did the exam but I am continuing to go, Yes.

CDV:

Anyway my question had referred, have you ever talked to someone from her Office to this question of murder, immediately above.

LM:

In that sense I apologize?

CDV:

She spoke to the lawyer from whom does practice?

LM:

Well I called him to report "Yes, Lawyer killed my roommate I don't know," sure, I was homeless, not ...

CDV:

When this?

LM:

I called the same day.

CDV:

The 2?

LM:

Yes.

CDV:

What time?

LM:

Verso l'ora di pranzo lo chiamai per riferirgli quanto era successo e infatti lui mi chiese se avevo necessità di stare da lui, di un appoggio, di un qualsiasi cosa, io dissi "No, risalgo con mio padre, la ringrazio" e lui mi chiamò per tutta la giornata per sapere se avevo bisogno di qualcosa, sì.

GCM:

Quindi lo chiamò quando stava ancora a Viterbo lei?

LM:

Sì, ancora stavo a Viterbo per dirgli cosa era successo.

GCM:

dopo la telefonata fattale da Romanelli Filomena, questo?

LM:

Sì.

GCM:

Prego Avvocato.

CDV:

Quindi prima di arrivare da casa, l'ha chiamato addirittura da Viterbo?

LM:

L'ho chiamato da Viterbo,

CDV:

La prima cosa che ha fatto ha chiamato l'Avvocato?

LM:

Non l'ho chiamato come prima cosa, ma io avevo preso un appuntamento... Cioè con lui il 5 dovevo fare una cosa a studio.

GCM:

Prego, prego Avvocato, proseguiamo, scusi Avvocato.

LM:

Il 5 dovevo essere presente ad un'udienza avevo reso questo impegno io con l'Avvocato e siccome non sapevo poi che cosa sarebbe successo lo chiamai e mi dissi "Avvocato è successo questa", mi sfogai un po', piansi un po', per organizzarci anche a lavoro.

CDV:

Ma anche successivamente si è consultata con l'Avvocato, si è fatta consigliare sugli sviluppi di questa questione?

LM:

No, questo no.

CDV:

Senta chiarimento sulla condizione di Rudy, lei ha riferito che aveva visto Rudy nella casa dell'appartamento sottostante, quella sera insieme agli altri ragazzi, come era Rudy Guede, in che condizione era, il suo stato d'animo come era...

LM:

I don't know why we exchanged barely a Hello.

CDV:

Had been drinking?

LM:

I think not.

CDV:

I the context this condition because she in the minutes of December 5 on page 2 information intakes says "downstairs along with Meredith, Amanda and Rudy, Rudy was added that back home he was drunk."

LM:

I apologize, I can report this condition? Because I only saw once Rudy was a Sunday, there were neither Meredith nor Amanda ...

GCM:

She said she saw one Sunday downstairs ...

LM:

A Sunday alone, on one occasion, he was 1 ' last race for Ferrari, when I saw there were no girls absolutely, there were only the neighbors. I couldn't have reported the opposite because it is not so.

GCM:

This is a verbal lawyer said of?

CDV:

Of 5 December 2007, I read a quote, "one of the boys who lived downstairs towards (ick.) He said he was in a pub with other downstairs, along with Meredith, Amanda and Rudy and he added that returned home Rudy was drunk ", remember?

LM:

Yes.

MC:

But there goes ... President when you make claims you can't, I mean, confuse even the heads in addition to the Court, this is a totally different circumstance.

GCM:

Excuse me, excuse me please.

CDV:

First of all I'm not confused anyone, I read in the minutes just to give a clarification.

MC:

Yes, this is a wrong and therefore not a legitimate dispute.

CDV:

I have asked for clarification about the conditions of knowledge of Rudy heads, which via traversa because he knew from another person who was drunk, that's all.

GCM:

We avoid a voice trying to overpower the other. We intended to advocate, but the witness reported seeing Rudy Guede on Sunday on the floor below, at least that's what I intended, on the occasion of a car race, the Ferrari that competed, and at that time there were girls and Rudy appeared normal. Here looks like something a little different, not referred to this condition as exposed by the heads then the dispute on contestation formulated so it seems to be accepted, but if there are further questions maybe.

CDV:

Who was this guy who she reports here in the minutes that would say that Rudy was drunk and then goes ...

GCM:

Pardon attorney, maybe we do demand. Do you remember if there was some guy that talked about Rudy?

LM:

Yes, Stefano downstairs.

CDV:

Stephen Ballard.

GCM:

What did he apologize?

CDV:

Remember also told him that he fell asleep on the toilet?

LM:

Yes, he told me that the boys were gone I do not remember well where if in a pub or Disco, Rudy had been drinking, had a slightly raised his elbow and he had fallen asleep in the toilet.

GCM:

Also because we are in the process of examination by the Lawyer so we avoid so-called suggestive questions, only the request, possibly the challenges ...

CDV:

No, but it was a cross examination that she ...

GCM:

Also under consideration.

CDV:

Yes, but we do it later.

FM:

No, this is the examination after the examination

GCM:

Agree with Advocate, moving on. You remember what he said?

LM:

He said that Rudy Guede had raised his elbow, was quite drunk and taking advantage of the boys ' bathroom he had fallen asleep on the toilet, I reported this condition.

GCM:

And I saw him, it was the same during the race?

LM:

No, no.

GCM:

It was another occasion.

LM:

It was another occasion.

GCM:

Before or after?

LM:

I think it was before.

GCM:

Before the vision of race car?

LM:

Yes.

CDV:

I consider myself to be in cross examination just to clarify because I have always done that, I've always done well in the days following, the exam ...

GCM:

Is contemporary, because it is exam ...

CDV:



On the condition that she reported seeing a striped sweater, can't show you a picture and ask if confirmed, this is the sweater ... When I had this sweater?

LM:

He wore it often.

GCM:

Who's had it?

CDV:

Amanda Knox.

LM:

He wore it all the time because it reminded her boyfriend so. ..

CDV:

The last time you saw him do you remember?

LM:

I remember no Lawyer, no.

CDV:

Look the day 3 0 you were together at girls in short of your apartment to discuss personal matters, remember?

LM:

Yes.

CDV:

Until what time?

LM:

Up to 3, 3 and a half hours because then we had to get back to work both me and Filomena.

CDV:

Do you know if Meredith went to College?

LM:

No no, I don't know a lawyer, which he intended to do next, I don't know.

CDV:

So you don't know what he did.

LM:

No.

CDV:

That's all for now, thanks.

GCM:

For exhausting the heads ...

Prosecutor Dr Comfy

MC:

Therefore President I ask permission since it was Let's say disputed that we showed the witness a black and white photo, I have the photos on the photo dossier of scientific police, however I have it on the computer and I can't disconnect right now, then the heads should be approached ...

GCM:

Yes, but maybe it's the same picture that showed ...

MC:

In color?

LG:

Yes, Public Prosecutor.

MC:

But the knife?

GCM:

No, the knife, the photo of the scratch.

MC:

No, not the scratch, the knife.

GCM:

Meanwhile, if there are other questions, so. ..

MC:

I found her.

GCM:

Also maybe you can see it.

MC:

Anyway if you want to see. Was provided at home, recognize it as a knife provided at home this knife?

GCM:

You are welcome. Maybe then we can also give indication and specification of the photo, which shows using your computer to the Prosecutor, which reserves to produce ...

LM:

No, we didn't have that knife.

GCM:

Then that knife was not supplied to the House.

LM:

No, was not at home that knife.

MC:

Just another question President, her first speaking of Raffaele and Amanda, who had put together recently, Raffaele spoke very affectionate, very present, was always behind and he said also, correct me if I am wrong, that his impression was that it was very possessive?

LM:

Yes.

MC:

And that she would bother us.

LM:

I do.

MC:

Instead Amanda had the same attitude, matched this type of attachment we say very strong?

LM:

To me it seemed to be happy I mean of these attitudes of Raffaele however just wasn't present as he say, he kept kissing her, you don't know softie in me was feeling that one day while she was cleaning dishes, washed dishes him the same behind embracing her, giving her the basins. She did not have the same behavior.

MC:

So the question were two lovebirds had a pigeon?

LM:

No no, she too was taken anyway, often slept at the home of Raphael.

MC:

I mean the definition pigeon is not of prosecuting attorney President.

GCM:

Please, continue.

MC:

The lovebirds were two or just one?

GCM:

How can you describe this relationship?

LM:

She also was taken by Raphael, God in a perhaps less possessive of him, but I guess, to me seemed happy to take this guy, I could see he often slept from him, were ...

MC:

But she had the same attention to Raffaele?

LM:

No, a little less.

MC:

Thank you.

GCM:

The Civil Parties?

A Civil Action-AVV. Mack

FM:

Sunday 4, you find yourself in the House of his friend to tidy up some ideas, there were strange behavior by Sollecito and Knox that she remember to indent each by the police?

LM:

No.

FM:

Or aside the questions she has already done defending Knox, so the fact that Amanda Knox had been heard about sex tell Meredith, vaseline, etc., you remember other things which occurred?

LM:

No, I don't remember, I don't Advocate seemed strange behaviors, were just a bit miffed by the constant requests from the police to go to the police station, complaining about something that they were ...

FM:

But there were all went to the police station in those days, Repeater?

LM:

We at least I speak from my position, I passed 2 day at police headquarters and riandai spontaneously on Sunday to report, if it could be useful and remembered with Filomena which-type of knives used in the House, though we called it so assiduously while against Amanda and Raffaele were often called to the police station for information, I do not know for what kind of activities but they were often invoked.

A Civil Action-AVV. Scaroni

SP:

Hear a clarification on what, on a claim that she did before, she said that the police told me nothing, I wanted to know: when she went to make his statement to the police, say there has been all night between 2 and 3, that information gave the inspectors, police, who questioned her, I mean who heard her said something about the event? That is, they told her that she had died, Meredith, who had been killed?

LM:

The only information I received that day was that I knew that Meredith had been killed with a cut throat, but this I I knew because I had received a call from some friends of my country who had read the news ...

SP:

On the internet?

LM:

On the internet Yes but there they told us nothing.

SP:

Nothing, no details, no?

LM:

No, no.

SP:

In the days after she learned a few details, that I speak of course before the arrest and detention of today's defendants?

LM:

Not if I learned some detail was simply from newspapers or the internet but not by police.

SP:

What kind, more like what?

LM:

Meredith had been raped and murdered with a cut to his throat.

SP:

This when I learned?

LM:

Already since the day after I guess, from the newspapers, I don't remember exactly but I was buying newspapers and reading the news on the internet continuously clearly to be informed ...

SP:

So let's say she doesn't fit the moment he learned the details?

LM:

No.

SP:

The police did not know absolutely nothing?

LM:

No, they told us these details, no.

SP:

Thanks I have no further questions.

Defense-AVV. Rocchi

DR:

Look in reference to when she came in Via della Pergola on 4 November and then later, I can report how was convened, how was convened, as they told her to go to Via della Pergola?

LM:

When I came back it was Sunday he went voluntarily to the police station myself and Filomena because we believed to be sufficiently informed about the knives we had in the House so we went there saying if we could be helpful in that way because we knew absolutely well such as knives we had in the House, and the police told us to wait, that Yes it would have been useful to see if it lacked some knife from the kitchen and ...

DR:

So was your initiative?

LM:

Yes, we go us.

DR:

And what time do you go to the police station?

LM:

I don't remember that.

DR:

Only she and Filomena?

LM:

It seems so. We accompanied because both we have no machines, so there probably accompanied his boyfriend but can't quite remember, but Yes at home we went just myself and Filomena.

DR:

In the House you enter just the two of you?

LM:

Yes, and the police.

DR:

On that occasion you signed the minutes?

LM:

I don't remember that.

DR:

You how you revenue?

LM:

They let us put some parascarpe say and gloves.

DR:

Even gloves?

LM:

Even gloves, they told us not to touch anything just so.

DR:

Even the cops had gloves?

LM:

I can't tell right at 100 percent but I think so, because all we were putting these things out the door, then I would report them too, but I wouldn't respond right at 100 percent but I think so.

DR:

But others have entered into other rooms?

LM:

No.

DR:

You which room you get in here?

LM:

In my room.

DR:

And Filomena?

LM:

Philomena saw it from the outside, they let her in, saw her through the door.

GCM:

She sorry she entered said in his room and in the living room?

LM:

I have entered my room and in the kitchen, the kitchen was the room to access all rooms then it should go in there.

DR:

And Filomena which room you get in here?

LM:

Philomena came into the kitchen and saw her room from the kitchen.

DR:

Thank you.

Defense-AVV. Curt

MB:



Just two questions, one about the knives, she said that there were so many knives you used some of them and others do not, according to all that you remember more or less number, roughly?

LM:

No.

MB:

They were 10, 20, 30?

LM:

I would say 30 but I do not remember, we had so many.

MB:

And these knives were readily available, that is, I mean, if one needed a knife opened the drawer and found or were hidden somewhere?

LM:

He opened the drawer and found it.

MB:

They were so, were not hidden? Perfect. The other clarification concerns, had hinted earlier at some annoyance at the police headquarters in continuous, ongoing meeting requests, say that some of you had matured.

LM:

Not us, Amanda and Raffaele ...

MB:

Well, what I was referring to. No, I was able to figure out if this Let's say a little bit of disappointment was due to the fact that Raphael was close to graduation, she was about to graduate, let's take time to study or not? If he heard something.

LM:

No, this condition was not out.

MB:

He knew Raffaele graduated shortly thereafter or didn't know?

LM:

I would say though I don't remember exactly, I'll probably get even asked what he was studying, so. .. Now I don't know.

MB:

So you don't remember, it may be that maybe she knew since the facts, so I don't know how to say.  
Okay thanks, done.

Defense-AVV. The Widow

CDV:

Coming back to scratching her when she noticed that scratch to Amanda came to mind to ask Amanda as ever ...

LM:

No, I asked her lawyer.

CDV:

He asked someone else?

LM:

No, no, I watched so much that day because I was afraid for her, I was afraid he was wrong, that ...

CDV:

But the reported someone else immediately "look that unusual there has a scratch"?

LM:

No.

CDV:

Even Solicitous asked why?

LM:

No.

CDV:

Then later, only after 1 ' preliminary hearing is reminded that scratch?

LM:

I this scratch I remembered it, only after the preliminary hearing has surfaced in the ears of the police as reported by Stefano, I didn't think to report this circumstance, there occurred to me and furthermore after I remembered to report ...

CDV:

Stephen heard from her?

LM:

Yes.

CDV:

Told in the car?

LM:

Yes.

CDV:

Going to Viterbo?

LM:

Yes.

CDV:

Because she excludes said in the minutes when the said, because it excludes that scratch could be a Hickey, called? We all know what is a Hickey, but why exclude him?

LM:

Because I saw hickeys and still differ from a scratch, scratch is usually ... The skin is raised, reddened, a Hickey tends to be blue, is a shape almost round, so know a little distinguerlo.

CDV:

The I can review the photograph that has already been filed which ... O however was shown magnified where you see that scratch? She now considers him a scratch?

MC:

Sorry but that is not the source of direct information of heads.

GCM:

Sorry ...

MC:

The source is own neck by Amanda.

GCM:

Sorry, he exposed the heads, though ...

CDV:

Though they referred to this document which, among other things, is annexed to the minutes.

MC:

Did the lawyer, you referred to the direct vision of the scratch.

GCM:

Okay sorry, though we all listened, the witness said, "I had seen that scratch on the photos I've seen on the internet, with the police, I remembered a little and together we found this photo".

CDV:

I'm wondering if in this photo she is a scratch or is a Hickey.

MC:

No, the question is inadmissible.

LM:

Lawyer in my opinion is a scratch but because I recall that was a scratch for that in this picture I see absolutely a scratch.

CDV:

I why I asked.

GCM:

The we acquire these pictures.

CDV:

Yes.

LG:

Let me produce ...

GCM:

Yes, of course in the end, if there are any other questions Lawyer and then eventually we acquire the production that has been disclosed by the Defense minded and so together we have.

CDV:

I wanted to ask: she was aware that Meredith had a boyfriend, had a relationship?

LM:

Yes.

CDV:

He attended Giacomo Silenzi and Meredith?

LM:

Yes, they were dating boys, I haven't seen him often ...

CDV:

And she consorted with them?

LM:

I saw them, clearly the neighbors, we did hang out often.

CDV:

But going to the movies, haunted ...

LM:

No.

CDV:

Never went to the restaurant with them?

LM:

We went Yes once in the restaurant all together.

CDV:

So have you attended?

LM:

Yes.

CDV:

There was also Amanda?

LM:

Yes.

CDV:

There was also prompt?

LM:

I don't remember maybe not.

CDV:

You can exclude or don't you remember?

LM:

I could exclude it though I don't remember exactly.

CDV:

She was in the apartment downstairs, knows the apartment downstairs?

LM:

Yes.

CDV:

She knew that there were planting marijuana in the apartment?

LM:

No, I didn't.

CDV:

She visited the apartment, do you know him?

LM:

The apartment Yes, except for one room, that room I've never seen her, but yes the apartment I know him, I saw him.

CDV:

He saw it all?

LM:

Yes.

CDV:

I ask to show footage of 8 seconds where you see the room where there are these seedlings, just to ask if I had never seen her this room.

GCM:

Yes, using his computer, maybe ... Is the room lawyer?

CDV:

Is one of the rooms in the apartment below. Are 8 seconds, maybe if you want to see her President, then even the prosecution. She remembers seeing her this room?

LM:

No, I didn't see this room.

GCM:

So it's useless that we see. You haven't seen her, is the room where there are plants, plants, plants look great.

LM:

Sorry, but the Attorney room cannot be seen, are seen only two walls and didn't see other ...

CDV:

No no, it's obvious, how do you see?

GCM:

So this room with these green plants didn't see her?

LM:

No, I haven't. Lawyer you see two walls, but do not see a bed ...

FM:

President, I beg your pardon, responded the heads, but you won't get a dialogue about an answer, is not the way. I understand but said no, you can't make a dialogue with the heads, President, does not the code.

GCM:

The witness gave answer I didn't see her. Did not see the heads this room, this part of the apartment below, didn't see her.

CDV:

Can I ask the witness if he saw in the video these seedlings?

LM:

Yes, I see, Yes.

GCM:

In the video that now is being shown.

CDV:

Yes, because he said he has only seen the walls.

LM:

No, I said I saw only the walls that did not make me identify a room, I don't understand what kind of room it is.

GCM:

The plants she saw them, he doesn't remember ...

LM:

The plants I see.

CDV:

The important thing is that he saw the plants ...

GCM:

She remembers seeing in the apartment below the plants?

LM:

No, I've never seen them.

GCM:

Plants thus made?

LM:

No, I haven't seen.

CDV:

Are you aware of the use of drugs by children downstairs?

LM:

I had seen them occasionally smoke hashish Yes.

CDV:

Also Meredith?

LM:

Meredith saw her only once.

CDV:

And she also participated in these ...

LM:

I attended a few times Yes.

CDV:

And even Amanda?

LM:

Yes.

CDV:

So it was a normal thing, one of your activities

LM:

It wasn't normal, happened on occasion, was not normal.

GCM:

Two occasions, how many occasions?



LM:

Two occasions Yes.

GCM:

On normal maybe evaluate.

CDV:

The normal was reported to the activity that was not extraordinary, it was one thing to normal a bit like drinking, like watching a movie, do something.

GCM:

Saw them on two occasions, drink, how many times have you seen them?

LM:

Maybe if we had a dinner you could open a bottle of wine, but really drinks ...

GCM:

We are at what we are told by the texts and then maybe guest Yes will do next, please.

CDV:

Look you, also on this point, she knew who was supplying the women in these substances?

LM:

No.

CDV:

She's never dealt with this?

LM:

No.

GCM:

Pardon Attorney, though we always also refer to article 198, paragraph 2.

CDV:

Of course, there is a limit, however, is the witness who may decide not to respond if there is a condition that can ...

GCM:

Well, if you sourced, please counsel, however is unaware of this aspect.

CDV:

I asked her if she knew how they did the supply since it's a fact ...

GCM:

And he said no, then there was a subsequent question on which you invoke the 198.

CDV:

LM:

Red.

GCM:

Bright red or red ... Red?

LM:

Red Yes.

GCM:

It was long since, as you remember. Longer than it is wide?

LM:

Longer than it is wide.

GCM:

And she thought of a scratch?

LM:

I thought I looked like a scratch a scratch, I repeat I brought laser much attention because I was afraid that Amanda could have been hurt, that is, I wasn't sure what had happened at home and I was concerned and for this I noticed, I looked at him almost assiduously that scratch, though that's not ...

GCM:

LM:

GCM:
