## EVIDENCE FROM THE WITNESS

## GATSIOS SPIRIDON

THE WITNESS WAS WARNED ABOUT ART. 497, PENAL PROCEDURE CODE, AND SWORE ON OATH.

DETAILS: Gatsios Spiridon, born in Greece on March 22 1981.

JUDGE - You have been called as a witness, you must tell the truth, you are warned about this obligation. Please go ahead.

# DEFENCE - Avv. Ghirga

DEFENCE - Avv. Ghirga - I am attorney Ghirga, part of Amanda Knox's defence team. We called you as a witness and we will ask you some questions. Please reply to the Court. You have already been heard at the Perugia police station, you were identified by your passport, issued by the Greek authorities in 2007. Do you remember?

WITNESS - I do.

DEFENCE - Avv. Ghirga - This remains the same, you are in possession of a passport, your authorization is in order.

WITNESS - Yes, yes. I am a student here.

DEFENCE - Avv. Ghirqa - How long have you lived in Perugia?

WITNESS - I first came here with my parents in 1999 to have a look at the town, and then I came back to attend the Foreigners' University in order to learn the language and afterwards I decided to stay here to study at the Faculty of Agriculture.

DEFENCE - Avv. Ghirga - In 2007 you were a student at the Faculty of Agriculture.

WITNESS - Exactly.

DEFENCE - Avv. Ghirga - Were you also working in November 2007?

WITNESS - Yes, I started to work in May 2007 in a coffee bar called Coffee Break in the centre, I was working as... there was also a small cyber cafè above the coffee bar and I looked after the computers three times a week.

DEFENCE - Avv. Ghirga - Is it located in .. (inc. - the microphone doesn't pick up)?

WITNESS - Yes, exactly.

DEFENCE - Avv. Ghirga - ...a side street to Corso...

WITNESS - Exactly, exactly.

DEFENCE - Avv. Ghirga - ... (inc. - the microphone doesn't pick up)?

WITNESS - Yes, yes, exactly.

DEFENCE - Avv. Ghirga - so there is a bar on the first floor?

WITNESS - Yes, and above there were computers which young people used for wireless and fixed computers.

DEFENCE - Avv. Ghirga - Do you mean a cyber cafè?

WITNESS - Yes, it was a cyber cafè, certainly.

DEFENCE - Avv. Ghirga - Was it there that you met Amanda? When did you meet Amanda?

WITNESS - Yes. I met her there because she came very often, to use the computers. She was talking to her boyfriend in the USA with a webcam and I was fixing it very often because there were many problems, and we made friends there, we talked many times.

DEFENCE - Avv. Ghirga - Friendship which continued with some meals together, in some meet-ups..?

JUDGE - Excuse me attorney, I have been informed that your microphone is not working.

DEFENCE - Avv. Ghirga - Perhaps it is switched off? You said on that occasion your friendship with Amanda started.

WITNESS - Exactly.

DEFENCE - Avv. Ghirga - What I am asking is if this friendship continued, having a coffee together, having a meal together, if you have been to Amanda's home, can you tell us?

WITNESS - Yes.

JUDGE - Attorney, what you were saying, given that before you couldn't be heard...

DEFENCE - Avv. Ghirga - What I was saying, Internet, in via Danzetta at Coffee Break there is a cyber cafè above...

JUDGE - Only because you couldn't be heard before.

DEFENCE - Avv. Ghirga - We said before that the witness, the Greek citizen, as well as being a student at the Faculty of Agriculture, also worked at Coffee Break in via Danzetta which is a side road to corso Vannucci, above the Coffee Break there is a small cyber cafè. He met Amanda there because Amanda went to speak via webcam to an American friend/boyfriend. Did you say this before?

WITNESS - Yes, later on we saw each other also outside, in the centre, we swapped numbers, we texted, we had a coffee, we were able to have a coffee in October, we met I think in late September, before October, I don't remember exactly, we went out 4-5 times to have a coffee, also the first time I went out with her for a coffee we went to hers, and she played the guitar because I couldn't play the guitar, I didn't know how to and she showed me a little. We also went out at Halloween, it was the only time we went out in the evening I think.

DEFENCE - Avv. Ghirga - I would like to ask you if, the time you were at her home to play the guitar, if you met Meredith?

WITNESS - Yes, when I came in she was inside, I remember she was reading a book, we introduced ourselves, and I remember that I went out onto the balcony and Meredith went away, I think she went into her room, she locked herself inside, I don't know, because I only said hello to her, then we went onto the balcony.

DEFENCE - Avv. Ghirga - Did you later meet Meredith on her own or together with Amanda on the cathedral steps?

WITNESS - Yes, I met them I think 2-3 times when they were together, one time they were on the steps together and I was with my friends, we stopped to talk together, we chatted together for about fifteen minutes, afterwards we left; I saw her later also other times either on her own or with her friends in the Merlin pub.

DEFENCE - Avv. Ghirga - Here are you talking about Meredith?

WITNESS - yes, now yes, then I saw Amanda and Meredith together once and I remember they were going to do the shopping, I was with my friends and I asked them to come for a coffee, they said "we are going to do the shopping and we'll see you".

DEFENCE - Avv. Ghirga - For the night of Halloween which is on the October 31, how, in what way did you and Amanda contact each other to meet, SMS, phone calls?

WITNESS - How did we organize it?

DEFENCE - Avv. Ghirga - We are taking about October 31, Halloween.

WITNESS - First we arranged to meet to have a coffee on the 31, we texted I remember either on the 31 or the 30 we texted to have a coffee together and went out for the coffee and then and then we met another young man who worked at the Coffee Break who had also become friends with Amanda who knew her and the three of us talked and we arranged...

DEFENCE - Avv. Ghirga - Could this young man be (Juve)?

WITNESS - I'm sorry? His name?

DEFENCE - Avv. Ghirga - That young man, that young man you met who you knew... could he be Juve, Juva, something..?

WITNESS - No, he worked with me at the Coffee Break.

DEFENCE - Avv. Ghirga - I made a mistake. Did you go out?

WITNESS - Yes, we said that we were going out, me and my friends and with my sister we were all going out together for Halloween and we said if she would like to come along with us and later she came out I think...

DEFENCE - Avv. Ghirga - Let's finish the night of Halloween. Did you leave Amanda at a certain time and where in Perugia?

WITNESS - Yes, can I continue..?

DEFENCE - Avv. Ghirga - We met I think around midnight, she came to meet us, we went round a few places in the centre, 2-3 places, we walked rather than staying in the places because there were a lot of people, and around two, 1:45 if I remember correctly, she told me that she was meeting that young Italian man she had met at the fountain. Me and my friends walked with her as far as the fountain then we said our good nights.

DEFENCE - Avv. Ghirga - So, that young man she had met, Amanda that circumstance to have met that young man who is Raffaele Sollecito...

WITNESS - Yes, she told me actually the afternoon of the 31 at the coffee bar...

DEFENCE - Avv. Ghirga - Before, some days before, did she tell you she had met a young man?

WITNESS - No, she hadn't told me, she told me that day because I hadn't seen her for several days, for 10 days, I had texted her to ask her "how are you? Let's have a coffee, I haven't seen you for ages"

and she told me "I have disappeared recently because I've met a young man..".

DEFENCE - Avv. Ghirga - Please explain calmly to the Court, had she met this young man?

WITNESS - Yes, she had met this young man I think at a concert and she told me "we went out together that's why I haven't seen you recently".

DEFENCE - Avv. Ghirga - And when you leave her the night of Halloween, after midnight, you think that Amanda was meeting this young man.

WITNESS - Yes.

DEFENCE - Avv. Ghirga - This is about all you remember from your friendship. Can it be said that it was a friendship? I realize it is a question...

WITNESS - Yes.

DEFENCE - Avv. Ghirga - But was there friendship between you, were there feelings, was there sex? What was your..?

WITNESS - No, absolutely not. There was friendship, an acquaintance because I define as friends the people I know well, but she seemed a person... she was very friendly to me, also with the other young people who worked at the Coffee Break, she smiled at everyone, in the sense that with my friends... she was very sociable in the sense that, I saw her as a friend.

DEFENCE - Avv. Ghirga - Had she ever spoken to you about a boyfriend, an American DJ?

WITNESS - Yes, she spoke about this young man.

DEFENCE - Avv. Ghirga - In what way?

WITNESS - I knew she was speaking to the young man because she told me when I was repairing the webcam, and afterwards she told me, I remember that on 31 Halloween that she was not too happy because she felt guilty that she had this boyfriend in the United States and then she met this new boyfriend here in Italy, she felt ill at ease and she asked me what I thought, in the sense that, how I saw things.

DEFENCE - Avv. Ghirga - I have finished this first reconstructive part. They are also in the statement that we could ask for, the SMSs that the witness and Amanda exchange on November 3 and 4, they are in English. I have a direct translation by Amanda yesterday morning and

by Attorney Dalla Vedova before, I would like to ask confirmation of these SMSs of November 3 and 4, thus after the fact, if you confirm them and remember them. As all parties have the statement, on the second page last period to the question he answers "I sent some messages". They are in English, can I read them?

JUDGE - Before let's ask the question if he remembers that they were...

WITNESS - Yes, yes, I remember...

DEFENCE - Avv. Ghirga - So you do remember? But as premised, you were honest on that point, if you remember to have texted, let's say, SMS, on November 3, November 4 with Amanda.

WITNESS - Yes, I remember she texted me at 3 in the morning.

DEFENCE - Avv. Ghirga - So do you remember then what was the first text, who texted first?

WITNESS - She texted me first on the 3 and she told me what had happened, in the sense that Meredith had been killed.

DEFENCE - Avv. Ghirga - She said that before she had come back home to call the police, do you remember?

WITNESS - Exactly, yes. Then I texted... that I knew already, that I had see it on television, that I knew.

DEFENCE - Avv. Ghirqa - How did you answer?

WITNESS - I answered "I saw, really terrible, if you need anything.." because she was new here in town, in the sense that I felt a little.... I wanted to help her in the sense that she felt bad, if I could do something. Then I texted her again, I don't know, the day after I don't know...

DEFENCE - Avv. Ghirga - On the 4.

WITNESS - I was out with my friends and I texted her...

DEFENCE - Avv. Ghirga - Excuse me, to help you, on the 4 was it you who texted?

WITNESS - Yes, I texted this time.

DEFENCE - Avv. Ghirga - What did you write her?

WITNESS - I was having a coffee with friends and I wrote "if you need... how are you? What are you doing?" something like that and I

asked her, "if you know well and if I can do something" I can't remember exactly "if I can help let me know" something like that.

DEFENCE - Avv. Ghirga - "Where are you?", did you say it to her?

WITNESS - Yes, exactly, "where are you?"

DEFENCE - Avv. Ghirga - "Do you remember how Amanda replied?"

WITNESS - Yes, I remember she said she was at home with the police. I remember it was only a little.

DEFENCE - Avv. Ghirga - And the texting stopped. WITNESS - Yes, we didn't speak any more.

DEFENCE - Avv. Ghirga - That's all. I'll ask if the messages also stopped after November 4?

WITNESS - Yes, we didn't send any more texts.

DEFENCE - Avv. Ghirga - Since then, apart from today obviously, from 4 to 6 did you see Amanda again?

WITNESS - No, since Halloween I haven't seen her again, since that evening.

DEFENCE - Avv. Ghirga - I would have some more questions to ask.

### DEFENCE - Avv. Dalla Vedova

DEFENCE - Avv. Dalla Vedova - Listen Mr Spiridon...

WITNESS - Spiridon, it's with an N, you made a mistake, I don't know how, it's how I was baptized.

DEFENCE - Avv. Dalla Vedova - So, Gatsios.

WITNESS - Yes.

DEFENCE - Avv. Dalla Vedova - So Mr Gatsios, which language did you speak to Amanda Knox in?

WITNESS - We spoke in English, most of the conversations were in English, in the sense almost always, because my friends don't speak English very well, sometimes we spoke a little in Italian because she spoke Italian quite well for someone who had been here for a short time, a bit of Italian, but mostly we spoke in English.

DEFENCE - Avv. Dalla Vedova - The e-mail, the SMS messages that you exchanged, what language were they usually in?

WITNESS - I think in English, not all though, I think that most were in English if I remember correctly now...

DEFENCE - Avv. Dalla Vedova - Listen, your cellular phone at the time, in November 2007, was it 329-3473230?

WITNESS - I still have that number now.

DEFENCE - Avv. Dalla Vedova - Because in fact I read in the Vodafone records already in the acts that on October 30 2007 you made a call, then another still on the 30, then another on the 30, who to? Oh, sorry, they tell me they were SMSs, so it was normal for you to also exchange SMSs.

WITNESS - Yes, because I sent texts I remember on the 30 to go for the coffee and she was at her lesson, and then I told her "come on, we'll do it on the 31" and we put if off till the 31 when we went out...

DEFENCE - Avv. Dalla Vedova - In fact on the 31 there was the text that we have... on the 30, the text that we have just translated into Italian.

WITNESS - No, I think that that one was on the 31, those texts were on the 31 because we had written a few SMSs on the 30 to have the coffee, she couldn't, so we wrote again for the 31.

DEFENCE - Avv. Dalla Vedova - So, I ask you to confirm, and if necessary I will also show you, here on the records there is one of your texts on the 30 that in English says... then maybe we can have it translated.

WITNESS - Yes.

DEFENCE - Avv. Dalla Vedova - (It is read in English). Maybe you can translate it?

JUDGE - If there is the interpreter.

INTERPRETER - "Why do you call me all the time? Why do you always call me during lessons? I can't today, but are you free tomorrow? I'm at work as well this evening".

WITNESS - This is the message I wrote on the 30 and she replied to me in that way, and I answered again "sorry, I didn't know you had a lesson, let's do it another day" I remember. Then I don't remember if she wrote me again or not, then we said "let's do tomorrow", then we wrote again "tomorrow..".

DEFENCE - Avv. Dalla Vedova - So you remember that on October 30 2007 that Amanda was in a lesson?

WITNESS - Yes.

DEFENCE - Avv. Dalla Vedova - In the afternoon?

WITNESS - Yes, she wrote that to me, in the sense that what she told me is that, certainly, yes.

DEFENCE - Avv. Dalla Vedova - To be precise this is the SMS that Amanda sent you in response to yours. Your Honor, in the records there aren't the SMSs received because I presume they were cancelled as we heard from the accused during the examination. Listen, returning to the relationships between the young women and above all with Meredith, you talked about an evening in the Gradisca discothèque where you saw Meredith.

WITNESS - Yes.

DEFENCE - Avv. Dalla Vedova - Together?

WITNESS - I was with my friends who I went on Saturdays to dance with and we met Meredith with her English friends that I saw, they were always together. We said hello in the sense because she too, Meredith too used to come to the Coffee Break and we saw each other around, and then a young woman, one of Meredith's friends was a little ill, she told me she was a little ill and they were always racing to the bathroom...

DEFENCE - Avv. Ghirga - Do you remember this young woman's name?

WITNESS - No, I didn't know Meredith's friends.

JUDGE - Which day are we on? Is it Saturday?

WITNESS - It is a Saturday in October, now I don't know, I can't know precisely.

DEFENCE - Avv. Dalla Vedova - In the statement of November 9 2007 you say "it was Saturday 13 or Saturday 20".

WITNESS - Yes because I remember there was Eurochocolate or something like that and so with the police in that way we found the date.

DEFENCE - Avv. Dalla Vedova - you also say that one of these friends was a little ill because she had drunk too much.

WITNESS - Yes, I remember that Meredith had said so.

JUDGE - Meredith, pardon?

WITNESS - She said so, that one of her friends was ill, she had drunk and was ill and they were going to the toilet, we said hello and then I didn't see her any more. Then I saw her again the day after on the steps where we met, she was with Amanda on the steps and I was with my friends, and I asked her "where did you disappear to that evening?" because we always came back on the bus and we know who is on the bus and I hadn't seen them. I asked her "how did you get back?" and she told me they had gone back with a friend of hers.

DEFENCE - Avv. Dalla Vedova - Listen, you said you had a friendship with Amanda, so you talked...

WITNESS - About general things, about life, everyday...

DEFENCE - Avv. Dalla Vedova - On the topic of her relationship with the other tenants and Meredith, but also with the others, I mean Laura and Filomena, did she ever tell you anything?

WITNESS - No. She never said anything bad, certainly nothing ever, I can't say anything good either because I think we spoke a lot about her co-tenants, she told me nothing I could report on.

DEFENCE - Avv. Dalla Vedova - Did you know her co-tenants apart from Meredith, Laura and Filomena?

WITNESS - No, not even by sight, because when I was there there was only Meredith, I don't know where the others were.

DEFENCE - Avv. Dalla Vedova - This is the time you went to the house.

WITNESS - When I went in early October there was only... I saw only Meredith.

DEFENCE - Avv. Dalla Vedova - Did you know Meredith's boyfriend, Giacomo Silenzi?

WITNESS - No, no.

DEFENCE - Avv. Dalla Vedova - Did you know any of the young men who lived downstairs?

WITNESS - No-one, no-one.

DEFENCE - Avv. Dalla Vedova - Listen, do you know Rudy Guede?

WITNESS - No.

DEFENCE - Avv. Dalla Vedova - Patrick Lomumba?

WITNESS - Yes, by sight yes.

DEFENCE - Avv. Dalla Vedova - Listen, after the body was found, so after November 2, you texted each other.

WITNESS - Yes, exactly on the 3 and the 4.

DEFENCE - Avv. Dalla Vedova - On the 3 and the 4. Your Honor I would like to reread the text of these messages as shown in the November 9 2007 statement because I would like to ask the witness what Amanda was like during those days, that day, how she seemed.

WITNESS - In the sense of which day?

DEFENCE - Avv. Dalla Vedova - On the 3 you sent a...

WITNESS - Oh, yes, yes! I understand.

DEFENCE - Avv. Dalla Vedova - At 09:57 you received a message which you show to the investigators while the declarations were being scrutinized and again in English it says: "(it is read in English and translated by the interpreter)".

INTERPRETER - "My room-mate was killed the night before last, and I was the first to arrive home and to call the police".

DEFENCE - Avv. Dalla Vedova - In relation to this did you speak after this SMS?

WITNESS - I relied to this text with another that asked if I could do anything as I had already found out through the television as I mentioned before.

DEFENCE - Avv. Dalla Vedova - And then at 11.30 Amanda sends you another text which says: "(it is read in English and translated by the interpreter)".

INTERPRETER - "I might do it later, I have to talk to the police today as well".

DEFENCE - Avv. Dalla Vedova - Then again on the same day, at 18.19 there is another SMS and evidently you reply to this one...

WITNESS - I don't think at mid-day, I think the next day because I texted her at the start then again the next day to ask how she was.

JUDGE - Excuse me, apart from the texts, did you ever meet Amanda again?

WITNESS - No, after Halloween that evening when I had left her there...

JUDGE - You never saw her again, just this contact...

WITNESS - Just these SMSs...

JUDGE - Messages.

WITNESS - Yes, to ask how she was.

DEFENCE - Avv. Dalla Vedova - I only ask confirmation of Amanda's new answer the next day that answers your question I imagine "(it is read in English and translated by the interpreter)".

INTERPRETER - "With the police at my house I am so tired". DEFENCE - Avv. Dalla Vedova - Do you remember this event? WITNESS - Yes, I remember.

DEFENCE - Avv. Dalla Vedova - Good, I have no other questions for the moment, thank you.

JUDGE - You're welcome, attorney.

# CIVIL PARTY - Avv. Pacelli

CIVIL PARTY - Avv. Pacelli - Good day Gatsios, I am attorney Pacelli, for Patrick's defence. Listen, you said you met Amanda when she came to this venue to talk to her boyfriend in the United States.

WITNESS - Yes.

CIVIL PARTY - Avv. Pacelli - When did this happen? The date, more or less.

WITNESS - The first time she came in?

CIVIL PARTY - Avv. Pacelli - yes, the first time you met her.

WITNESS - It could have been late September, I think late September, I think so.

CIVIL PARTY - Avv. Pacelli - Late September. Listen, this acquaintance started. Did you always text, always use SMS?

WITNESS - No, we also talked on the phone!

CIVIL PARTY - Avv. Pacelli - Yes, yes, but I mean, to meet up, to arrange to meet, to fix times?

WITNESS - Yes, we always did so, in the sense that in the afternoon when I was about to go out for a coffee we texted "if you can, let's go out for a coffee".

CIVIL PARTY - Avv. Pacelli - The sense of the question was: the normal way of communication between you and Amanda was texting.

WITNESS - Yes, Yes! I think so, we also spoke on the phone, in the sense that we texted more than we called, she might have called ma a couple of times, I don't remember exactly, more texts though. To go out, certainly texts.

CIVIL PARTY - Avv. Pacelli - So the use of SMSs was absolutely normal.

WITNESS - Yes, yes, certainly.

CIVIL PARTY - Avv. Pacelli - Thank you Your Honor, I have no other questions.

JUDGE - You're welcome.

### DEFENCE - Avv. DONATI

DEFENCE - Avv. Donati - Just one thing. Listen, the first time that Amanda told you she had met a young man, what date, if you remember the date, when is it?

WITNESS - It was the 31, when we had a coffee at Halloween and we talked about going out in the evening it was that day, the 31.

DEFENCE - Avv. Donati - So that day was the first time she mentioned this young man?

WITNESS - Yes, yes, exactly.

DEFENCE - Avv. Donati - Did Amanda tell you how long before the 31 she had met him?

WITNESS - Yes, she told me she had met him at a concert at the Foreigners', at the Foreigners' University.

DEFENCE - Avv. Donati - Do you remember if it was a classical music concert?

WITNESS - Yes, perhaps yes. I think it was a week, ten days before because I said that it was a while since we'd met, "how are you?" and she said "I've met this young man, that's why" I said "Oh, tell me about him".

DEFENCE - Avv. Donati - So a week, ten days before the 31 as far as you remember, very good.

WITNESS - Yes, yes.

DEFENCE - Avv. Donati - Do you know Raffaele Sollecito? Have you every seen him? Have you ever seen him in the places you go to Merlin..?

WITNESS - No, never.

DEFENCE - Avv. Donati - You have never seen him.

WITNESS - Never.

DEFENCE - Avv. Donati - Thank you, no more questions!

JUDGE - You're welcome, attorney.

#### DEFENCE - Avv. Dalla Vedova

DEFENCE - Avv. Dalla Vedova - Just to clear up something regarding the cyber cafè. Do you work or did you work at the cyber cafè?

WITNESS - I worked part-time, in the sense three days, it depends, three four times...

DEFENCE - Avv. Dalla Vedova - And did Amanda often come into the cyber cafè?

WITNESS - Yes, yes, very often.

DEFENCE - Avv. Dalla Vedova - Because she spoke to her family via Internet?

WITNESS - I don't know who she spoke to every time but she told me she spoke to a boyfriend who lived in the United States who was her boyfriend since 2007, I don't always know what she was doing.

DEFENCE - Avv. Dalla Vedova - Can you be more specific and tell the Court how you talk to someone with a computer?

WITNESS - Oh, I mean she opened programs such as Windows Messenger, Skype, a lot of programs and you can connect yourself with a webcam that's the camera and you can contact your friends to talk to them.

DEFENCE - Avv. Dalla Vedova - Do you know if Amanda Knox had an Internet connection at home? Did she ever tell you?

WITNESS - She never told me but I think that if she came in now and again... I don't know, I think not because she always came to the

cyber cafè, so I suppose not as you pay one Euro I mean (inc.) there, it's quite a lot.

DEFENCE - Avv. Dalla Vedova - I understand thank you!

#### JUDGE

JUDGE - I just want to ask you, have you been to the Via della Pergola house only once?

WITNESS - Exactly...

JUDGE - You have been there only once?

WITNESS - Yes, in early October.

JUDGE - Early October?

WITNESS - Yes, exactly. It was the first time we went out with...

JUDGE - When you went you met Amanda Knox and Meredith?

WITNESS - No, I went together with Amanda inside the house because we had gone for a coffee and after the coffee she had said "do you want to come to mine to hear me play the guitar?" I said "yes" and we went in and there was Meredith there and she introduced me "Spiridon... Meredith" and then we went out onto the balcony and she played the guitar and I listened and tried to do something.

JUDGE - And Meredith went into...

WITNESS - Meredith went away, because we said hello, I went out onto the balcony and I came back and Meredith was no longer there, I mean she had gone away.

 ${\tt JUDGE}$  - Because you said at a certain point that she went into her room and closed the door.

WITNESS - Yes, I think she went into her room because I think it was open before and later closed, I think so because in my head she had gone into the room, that's what I thought.

JUDGE - When you went out you found Meredith's room closed.

WITNESS - Yes, there was no-one else, the room was closed.

JUDGE - Did you see if the doors to the other rooms were closed on that occasion? If you remember.

WITNESS - I don't even remember the other rooms to tell you the truth!

JUDGE - But when you went out Meredith's room was closed.
WITNESS - Yes, I remember there were two rooms, yes it was closed.
JUDGE - Fine, there are no other questions.
There are no other questions; the witness is discharged.
